## You CAN afford to attend.

Yuma Catholic Students received more that \$4.2 million in tuition assistance in 2020-2021 which averages \$8,700.00 per student.

- All Yuma Catholic High School Students
  <u>aualify</u> for tuition support through the
  Arizona Tax Credit Program or the Universal
  Empowerment Scholarship Account
  Program regardless of the family's income.
- Low Income/Corporate Scholarships are available to those who meet specific income guidelines.
- Tuition Discounts may be given to families with multiple students, and those with parish memberships that contribute to YC.
- Private Scholarships are available from generous benefactors and need be applied for individually.

### School Tuition Organization (STO)

Arizona allows individual tax payers to re-direct their tax dollars by making a dollar-for-dollar contribution to STO's and recommending the funds for your child. With a little planning on your part, tuition can be significantly reduced with the support of family, friends and co-workers.

#### **New! Universal ESA**

The Universal ESA now gives students 90% of the State Aid funds that would have gone to the student's school district if the student had remained in the public school system. This Scholarship is available to all Arizona Residents but cannot be combined with any other scholarship from a Tuition Organization. Scholarship awards for the 2023-2024 school year based on Yuma County Residence is \$7,700. This Scholarship cannot be used in conjunction with scholarships from STOs.

### **Corporate Scholarships**
