### **Submit the Financial Aid Independent Review (F.A.I.R.) application**

## WHAT IS FAIR?

F.A.I.R. is the application that allows students to be considered for tuition assistance awarded to students by the YCHS Tuition Assistance committee. To be considered, begin the application as soon as possible. No awards can be given until the application is complete, with all tax information from the previous tax year.

### **Submit the School Tuition Assistance of Yuma (S.T.A.Y.) application**

### **Submit the Yuma’s Education Scholarship Fund for Kids, Inc. (Y.E.S.) application**

1. For consideration for external funds from individuals and corporations

3. Open June 1<sup>st</sup> – January 31<sup>st</sup>

### **Talk with friends, family and neighbors about re-directing their Arizona state taxes to offset your child’s tuition.**

1. When they file their taxes, Arizona taxpayers earn credit for the full amount contributed (up to \$2,177 if married and filing jointly)
2. Find as many contributors as you can.
